### **Meeting Minutes**

### **Police Report**

Officer Joe Creitz thanked the Village on behalf of the Sunbury/Galena Police for the snow and ice removal during the last few weeks.

### **Mayor's Proclamation**

Galena Mayor Tom Hopper recognized Boy Scout Zach Wagner with a Mayor's Proclamation for attaining Eagle Scout Status. Wagner refurbished the Big Walnut Elementary Land Lab as his Eagle Scout project. He is a member of Boy Scout Troop 300 based at the Galena United Methodist Church.

### **Guest Participation**

Greater Galena Civic Association (GGCA) leaders Jane White and Travis Eifert made a presentation to Village Council about plans the group is making to celebrate Galena's Bicentennial this year. The GGCA plans to have a celebration on August 29 that would include a Jazz and Blues Fest with a beer tent on the square. The event may include an Artists Alley and historical horse and carriage tours of the Village.

### **Payment of Invoices for January**

Ed Karn made a motion to pay the invoices for January and Chris Underwood seconded the motion. The motion passed in a 6-0 voice vote.

### Fiscal Officers Report

Fiscal Officer Marty Mazzie reported to council that the sewer fund was \$42,500 in the red at the end of 2008. She recommended at least a three percent increase in sewer fees which would cost residents \$1.14 per month or \$3.43 per quarter more on their sewer bills. This would increase income to \$152,016 per year. Mazzie also reported that the Village's 2-mill property tax levy will expire in November 2009. She explained that this money has been offset by the loss of gas tax funds the Village was receiving. The current levy costs residents \$55.23 annually (\$4.60 per month) per \$100,000 home real estate value. Mazzie said another option is to increase the existing one percent income tax. An additional ¼ percent income tax would generate approximately \$57,000 in revenues for the Village and a ½ percent increase would bring in approximately \$115,000. After reviewing all the options, Mazzie recommends the Village would need a 3-mill property tax which would cost residents an additional \$36.66 annually or a ¼ percent income tax increase (to a total of 1 ¼ percent) just to stay at revenue levels similar to the beginning of 2007.

Fiscal Officer Marty Mazzie brought to Council's attention an outstanding bill from Poggemeyer Design Group for the "Galena Land Use Plan Update". The total of two bills is \$4,702.50. Roberta Miller made a motion to pay Poggemeyer Design Group half of the payment this month. Ed Karn seconded the motion. The motion passed in a 6-0 voice vote.
