Don Grubbs – Judge Candidate for the new Delaware County Municipal Court Judgeship introduced himself to Council and briefly discussed his judicial candidacy, philosophy and plans for the court. He passed out literature so people could be informed and ask questions.

Nancy Hood and Bob Croce from the Eastern Delaware County Joint Recreational District presented printed materials with frequently asked questions and a drawing of the projected building site (attached). The Community Center will benefit the entire community through employment opportunities, as an incentive to attract new business to the area and simply as a gathering place for families.

Eastern Delaware County Joint Recreational District

Roberta Miller reported the committee has been working on setting up a Mission Statement and Purpose. They are also working on the campaign for the May 8th election to pass a levy to finance this project along with private donations which are being raised to build the outdoor pool. The EDCJRD is seeking a 1.2 mil, 27-year levy. This levy would cost the owner of a \$100,000 home approximately \$36.84 annually according to Delaware County Auditor Todd Hanks. Under Pending Matters council authorized Dave Lavalle to sign the contract for Professional Engineering Services the FY 2006 CDBG Curbs and Sidewalk Project between the Village and PDG.

BST&G Fire Board Report

Jim Slifko reported the audit passed. Papers were filed to renew the five-year, 2-mil replacement property tax levy for the May 8^{th} ballot.

Parks & Special Events Committee Report

Easter Egg Hunt is scheduled Saturday, April 7th, 1:00 pm at Ruffner Park rain or shine. Charlie Chandler from the Sunbury Police Department is scheduled to be on hand for safety.

Zoning and Planning Commission Report

Mayor Hopper reported Commission members approved the Mud Flats Bar to put a deck on the back for smoking and eating. The Commission recommended the deck be lowered two feet and that they have a six foot privacy fence around perimeter of property. The Commission is allowing them to serve on the deck until 10:00 p.m. or thirty minutes past sundown. There are to be no amplified noises outside. The Commission is allowing a new sign on the front of the building above the awning which may not protrude past the awning. They will be constructing an enclosure around the dumpster.

Nancy Feole attended Health District Annual Meeting. There is nothing new to report that the Newsletter will not cover.
