On Monday, April 27, 2009 the Village of Galena Council meeting was called to order at 7:05 p.m. in Council Chambers of the Municipal Building, 9 W. Columbus St., by Mayor Tom Hopper.

Meeting Minutes

Roberta Miller made a motion to approve the minutes of March 23, 2009 as corrected. Nancy Feole seconded the motion and the motion passed unanimously in a 5-0 voice vote to adopt March 23, 2009 minutes as corrected.

Police Report

Officer Joe Creitz had nothing to report.

Guest Participation

Delaware General Health District representatives Joan Bowe and Jesse Carter addressed Council. They offered a Swine Flu Advisory and explained that symptoms of the flu include fever, body aches, runny nose and/or sore throat, and nausea, vomiting and/or diarrhea. Persons with these symptoms who have traveled to areas where there have been Swine Flu outbreaks should see a doctor. Residents can protect themselves by washing their hands frequently with warm water and soap; covering coughs and sneezes with their sleeves or tissues; and staying home if they are sick.

Bowe and Carter also reviewed the district's goals and objectives related to chronic diseases; communicable disease control; protecting the water supply; promoting recreation; food safety environments; healthy youth; agency infrastructure; and air quality.

Payment of Invoices for April

Ed Karn made a motion to pay the invoices for April and Roberta Miller seconded the motion. The motion passed in a 5-0 voice vote.

Fiscal Officers Report

Fiscal Officer Marty Mazzie submitted a current report of the delinquent sewer bills and the updated spread sheet as of the end of March 2009. Mazzie also reported that the Village can save a significant

Auditors, Julian & Grube, Inc. submitted an audit report which overall was good and much improved from past years. Tara Logan suggested that Council make a motion to receipt interest revenue from sewer sweep account 1575 into the sewer interest account.

Public Service Directors Report

Scott Jamison's report is attached. Jamison shared a report with Council from Scott Watson of Miller/Watson Architects regarding the Village's building at 109 Harrison Street, formerly the Galena United Methodist Church. The company had mechanical, structural, and electrical engineers evaluate the building. Watson recommended that the building would need revised handrails and door openings as well as two new restrooms to be compliant with the Americans with Disabilities Act. (ADA). Ventilation and fire alarm/emergency lighting revisions are needed as well as changes in the kitchen. Costs to make the building ADA compliant are estimated at \$50,000 to make the building ready for Village offices. Council held a first reading on an ordinance to sell or lease the building.

Delaware County Regional Planning Commission Report

Mayor Tom Hopper had nothing to report.

BST&G Fire Board Report

Ed Karn reported BST&G Fire District updated one of their fire trucks. They purchased a new cab and chassis and used an existing rescue body. The updated truck has a tight turn radius and can turn around in three lanes of traffic.

Zoning and Planning Commission Report

Columbus Street with a new sign reading Galena Diner to replace the Jul's Java and Grille sign.
