Sewer Plant Design

Bob Jablonski reported he has not heard from Congressman Pat Tiberi regarding funding for repaving Walnut Street. This project has to be sponsored by a Congressman in order to receive grant money.

Public Service Director's Report

Scott Jamison's report is attached. He reported that Joe Walker Road reconstruction is complete. Jamison is working with the City of Columbus and the Village solicitor's office on a lease agreement to build a parking lot at Columbus and Front streets. He reported that road salt cost increased 42 percent over last year. The Village will be able to buy salt from the Delaware County Engineer's Office at their cost of \$61 per ton.

Wastewater Treatment Plant Report

Dale Davis of PPPS has been contacted regarding a reduction of service to help the Village cut costs. Jamison reported other improvements that need to be made to reduce overall cost of maintaining the sewer plant. The goal is to reduce the cost of basic service by 65-70% by replacing manual service with technology.

Administrative Assistant's Report

Administrative Assistant Jeanna Burrell reported that damage estimates from Hurricane Ike totaled \$6,000 and \$12,500 in Village expenses. These figures were submitted to the Federal Emergency Management Agency (FEMA) and the recent presidential disaster declaration should mean the Village recoups those costs. Burrell reported that a solid waste hauling and recycling bid package was developed. A legal notice was placed, inviting trash haulers to bid on providing services Village-wide in a three-year contract. A pre-bid meeting is scheduled for November 7, with a bid opening meeting on November 17, 2008
