Clerk Mazzie suggested the need to transfer funds and Resolutions should be drawn up for this purpose in keeping with requirements by UAN and the auditors.
Resolution 2006-22 was submitted to transfer funds to cover the cost of salaries and payroll. Resolution 2006-23 was submitted to transfer funds for utilities to finish the year.
OPERS contribution rate increase to 9.50 is effective January 1, 2007.

Sewer Plant Design

Dave LaValle reported for Bob Jablonski the Sewer Plant Design is on schedule and will be ready the end of December.

Wastewater Treatment Report

Scott submitted a written report. A fourth overflow was observed and reported.

Public Service Director's Report

Public Service Director Dave LaValle submitted a report for council to review. Scott's attorney's fees of \$843.75 for his deposition with the Berkshire Campground was discussed and will be considered at the organizational meeting next month at which time a policy will be set forth for future reference. There was a discussion about the sidewalks in town. Dave and Mayor Hopper will do some research with Poggemeyer and report back to council. Dave reminded Mayor Hopper that Stan Swisher's term on the Zoning and Planning Commission has expired and needs to be reappointed. Dave Simmons made a motion to reappoint Stan Swisher for another three year term on the Zoning and Planning Commission and Jim Slifko seconded the motion. The motion was passed by a 6-0 voice vote.

Delaware County Regional Planning Commission (DCRPC)

Tom Hopper had no report as he and Dave LaValle were unable to be at the meeting.

BST&G Fire Board Report

Jim Slifko reported that there was a fire at the Big Walnut Middle School.

Zoning and Planning Commission

Tom Hopper reported that Stan Swisher was reappointed to the committee.

Parks and Special Events Committee Report

Nancy Feole wanted to commend Mike Hamilton for the great job he did in reconstructing the wagon for the Village. It was used for hayrides at the tree lighting the first Sunday in December and again for the children who came to visit Santa. There were 70 children that visited Santa and it was a big success. Karen Underwood submitted a budget for next year.

Eastern Delaware County Recreational District

Roberta Miller reported that they had a working session to set up committees. Roberta is in charge of researching grants.

Executive Session

Dave Simmons moved to adjourn to Executive Session to discuss pending litigation, real estate purchase and personnel. Jim Slifko seconded the motion. All agreed in a 6-0 roll call vote:
