

## **Council Hears About Low Crime Rate**

Delaware County Sheriff Russ Martin reviewed crime rates for Galena's Village Council at their November meeting. He explained that his office is charged with law enforcement and public safety, court support, and operating the jail. He also explained resources available online at <a href="http://www.co.delaware.oh.us/sheriff/">http://www.co.delaware.oh.us/sheriff/</a> such as the tip line and the sex offenders registry.

A new resource, Raids Online, allows you to view real time crime updates and receive customized alerts. Enter your address, timeframe, and select all crimes at <a href="http://www.raidsonline.com/?">http://www.raidsonline.com/?</a> address=delaware,oh. You can scroll over incidents near your home to see what the details.

Martin said incidents in the Village dipped from 41 in 2013 to only 17 in 2014 and have trended back up to 33 so far in 2015. Martin recommended tips to prevent theft including locking your doors and windows. With cars, conceal valuables in the trunk, under a seat, or covered from view. Remove all valuables from your vehicle and park it in your garage. If you cannot park in a garage, park near a light and take your garage door opener inside the house. Leave your house lights inside and out on when occupied or not.

Martin encourages residents to call his office at 740-833-2800 to report anything suspicious and be sure to note location, time, date, descriptions of persons and vehicles, and direction of travel. Always call 911 in an emergency.

## Administrator's Updates

Village Administrator Jeanna Burrell noted that the Galena Village Hall restroom project is ahead of schedule with rough plumbing, electric, heating and ventilation; framing, and drywall completed.

She also discussed ongoing repairs to the Village's Chevrolet plow truck. Brakes, steering, gas, and transmission lines have been repaired due to corrosion from the salt. Ongoing repairs are expected but having the new GMC plow truck will help when the larger truck is in for repairs. Burrell told Council it is time to start planning to replace the Chevy.

Burrell has been working with Del-Co Water Company to repair the leak at the stoplight. Del-Co

crews have been unable to find the source of the leak and may have to start digging in order to repair it before freezing weather causes a hazardous condition.

## **Money Matters**

Fiscal Officer Marty Mazzie noted that staff are drafting 2016 budget plans that will go to the Finance Committee which will forward a recommendation to Council. The Income Tax Committee will meet to review the Village's income tax ordinance overhaul to bring it into compliance with new state law changes. Beginning of the year staff and contract resolutions received a first reading.

## **Developments**

In zoning and property maintenance news, Homewood Corporation President Jim Lipnos attended this month's Zoning Commission meeting to discuss revisions to the Miller Farm development plan. Del-Co Water has asked that a water tower be included. The developer is revising the Sunbury Road entrance and some of the street layouts. The changes will include a clubhouse and pool but will not affect density. Homewood is working on sewer line easements but due to water tower construction timeframes, the development construction will most likely not occur now until 2017. After a third reading, Council voted to extend the Miller Farm development plan three more years.

## **Winter Prep**

Maintenance Supervisor Josh Cherubini noted that grit has been added to the brick portion of Walnut St. 2015 chipper days have ended and snow plowing equipment is being prepared for the winter. Remember, in a snow emergency (when accumulations of ice or two or more

inches of snow are expected or received in a 24-hour period) all cars are to be removed from Village streets. This accommodates faster and safer snow removal and salting. If you do not remove your car and it interferes with snow removal, it can be towed at your expense. We thank you so much for your assistance in this matter.

#### **Wastewater News**

Fourth quarter sewer bills were sent out Nov. 2 and are due Dec. 10. Residential sewer bills are \$54.45/month (\$163.35/qtr.). Pay your bills in a timely fashion to avoid late payment penalties, property tax liens, and other legal actions. Payment options are noted on the Village's web site. Quarterly billing saves customers money, so paying on time is crucial according to the following calendar.

Staff is recommending a three percent increase in sewer bills for 2016 consistent with an Ohio Rural Community Assistance Program recommendation and Delaware County cost of living increase figures. Council will consider the rate increase as part of the budgeting process in December and January.
