Trails

Mary Kerr represented Delaware County Friends of the Trail at the October Council meeting in an appeal to Galena Village Council to share in funding of engineering services for Galena area trails. Kerr said the trails project from Plumb Road to Dustin Road would cost \$695,000. She hopes to apply for a Clean Ohio Fund Grant for \$521,250 with 25 percent matching funds from local entities.

Kerr is asking Delaware County to pay \$71,000, the City of Columbus to contribute \$51,000, Berkshire Township to add \$44,000, and the Village of Galena to pay \$7,702.50. Kerr explained that initial trail estimates were \$1.3 million but the project was pared down by deleting the pedestrian bridges crossing Plumb Road and S. Old 3C Highway as well as Dustin Road improvements. The Dustin Road to Walnut Street portion of the trail will not be included in the project at this time.

The Village's funds would be for design and engineering services. The Delaware County Engineer will prepare the grant application which is due in February 2006.

Clerk Progress

New Acting Clerk/Treasurer Stephanie Paese reported to Galena's Village Council about progress with the Village's accounting system. Paese, Acting Assistant Clerk/Treasurer Michele Dearth, and Visiting Clerk Debbie Farley have spent a great deal of time getting bill payments current; reallocating income and expenses to appropriate accounts; and getting that data entered into the Village's Universal Accounting Network (UAN) computer system.

Paese reported that the books have been brought current and there has been no need at this time to borrow funds to bridge the gap. Council approved reallocation of funds among accounts.

Police Contract

Village Council accepted the Village Security Committee's recommendation to proceed with negotiating a new contract for police services. Village Solicitor Ken Molnar will work with the Village of Sunbury on a new contract. The existing contract does not expire until September 2006.

Sewer News

Sewer bills went out in late October for the billing quarter November, December, and January. The bills are due Dec. 10 and should be paid to Water Quality Management.

After meeting with the Berkshire Campgrounds' owners, the Village has requested information from the owners about their OEPA permits, inspections, and other details about their sewer system.

Playground Grant Application

A grant application was submitted to the Preservation Parks of Delaware County for \$5,395 for safe surfacing around the Ruffner Park merry-goround.
